“Minimum Qualifications for Teachers & staffing pattern in  
Physiotherapy College Jharkhand Regulations 2020”.

**THE JHARKHAND STATE COUNCIL FOR PHYSIOTHERAPY, RANCHI**

1. (i) **Short title and commencement:** These regulations may be called “Minimum Qualifications for Teachers & staffing pattern in Physiotherapy College Jharkhand Regulations 2020”.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

1. **Objective:-** The objective of this regulation is to prescribe the minimum qualification requirements, staffing pattern for teaching posts in the Physiotherapy colleges imparting graduate and post-graduate Physiotherapy education to meet necessary requirement to maintain the standard of physiotherapy education.

2. **Definitions:-**

- (1) In these regulations, unless the context otherwise requires, –
  - (a) “Act” means the Jharkhand State Council For Physiotherapy Act 2020;
  - (b) “Government” means Jharkhand State Government
  - (c) “Council” means the Jharkhand State Council For Physiotherapy established under the Act;
  - (d) “Physiotherapy college” means any institution, college or a body by whatever name called, in which a person may undergo a course of study or training which will qualify him for the award of recognised physiotherapy qualification.
  - (e) “Intake capacity” means maximum limit for admission permitted by government
- (2) Words and phrases used in these regulations and not defined but defined in the Act shall have the meaning respectively assigned to them in the Act.

1. **Minimum qualifications for appointment as a teacher:** Minimum qualifications for appointment as a teacher in various departments of a physiotherapy college or institution imparting graduate and post-graduate education shall be as specified in the Schedules I, the required number of teaching staff in II annexed with these regulations and required primary and equivalent qualifications in schedule II.
2. Every appointing authority before making an appointment to a teaching post in Physiotherapy college or institution shall observe the following norms:
  1. All Physiotherapy teachers must possess a recognised University’s postgraduate qualification. They must also be registered in a State Physiotherapist’s Register prepared under Jharkhand State Council for Physiotherapy Council Act.
  2. The appointing authority will make sure that the candidate has valid council registration certificate and additional qualification registration certificate at the time of appointment. Unregistered persons and persons without additional qualification certificate shall not be appointed by appointing authority.
  3. Teacher appointments done without valid council registration and additional qualification registration shall be considered invalid. A penalty of rupees 10000 per teacher appointment shall be charged from appointing authority on violation of clause 5.2.
  4. The maximum age limit up to which a person can be appointed or granted extension or re-employed in service against the posts of Teachers or Dean or Principal or Director, as the case may be, which are required to be filled up as per the norms of Jharkhand State Council for Physiotherapy in any Physiotherapy College or Teaching Institution for imparting Graduate and Post-Graduate medical education, shall be 62 years.

5. The maximum age limit of teachers of Medical subjects shall be as per the criteria laid by Medical Commission of India.
1. Teachers of medical subjects in all Physiotherapy Colleges must possess the requisite recognised Postgraduate Medical qualification in their respective subject & shall meet the criteria laid by Medical Commission of India.
1. Every medical subject department shall have at least one senior teacher i.e Professor or Associate Professor and one junior teacher i.e Assistant professor for colleges not having their own medical college.
2. The appointing authority may consider the holders of equivalent postgraduate qualification, which may be approved by the Jharkhand State Council for Physiotherapy from time to time, to have the requisite recognised qualification in the subject concerned as mentioned in schedule III of this regulation
3. The Jharkhand State Council for Physiotherapy shall determine equivalent qualification referred to in these regulations and may modify or change or remove or amend as may be as per need.
4. The experience of teacher appointed in the designation of Assistant lecturer prior to came into existence of this regulation shall be considered as valid experience and such teachers shall be eligible for the next promotion. No teacher will be appointed as Assistant lecturer or Lecturer after came into existence of this regulation.
5. Candidate with primary required qualification (Schedule III) shall get preference over candidate with equivalent qualification.
6. Higher qualification shall get preference for selection for teaching post.
7. The Equivalence certificate issued by the equivalence committee of Jharkhand State Council for Physiotherapy shall be mandatory for teachers who have acquired under graduate or post graduate qualifications from universities situated outside India.
8. In the absence of equivalence certificate the overseas qualified candidates shall not be considered eligible for teaching post.
